Intent

This declaration, while not a binding legal contract, is however a statement of good faith and commitment of the undersigned parties.

This is a commitment by the undersigned parties that they will work in collaboration with the Lloyd EcoDistrict to help sustain, advance, and implement stated goals and objectives addressing neighborhood resiliency, climate responsiveness, and a socially equitable neighborhood for all who work, live, and recreate in Lloyd.

It is our shared understanding that this is a living document that will evolve over time as the roadmap is implemented and additional stakeholders are engaged.

Background and History

The Lloyd neighborhood was identified as a potential “EcoDistrict” in the spring of 2009 based on discussions between the City of Portland, the Portland Development Commission (PDC), the Portland Sustainability Institute (PoSI), and key neighborhood property owners interested in creating a green district. Over the spring and summer of 2009, a Governor-designated Oregon Solutions project brought these key stakeholders together and established the Lloyd Green District Oregon Solutions Project Team. This team was convened by then-Mayor Sam Adams, Multnomah County Commissioner Jeff Cogan, and Metro President David Bragdon to create a Lloyd Green District Guidance Strategy. Their task at the time was to:

- Develop and prioritize District sustainability goals, objectives and metrics;
- Prioritize potential “showcase projects” that would directly address priority goals and objectives in five potential project categories; and
- Develop principles of sustainable District management and investment.

A broad group of private and public sector stakeholders committed to a three-year partnership to guide these efforts. Partners included the Lloyd Business Improvement District (LBID), the City of Portland, the Portland Development Commission, the Portland Sustainability Institute, and Metro. A declaration by both public and private partners established the formation of a “Lloyd EcoDistrict” as a high priority with regards to business competitiveness, marketability, risk mitigation, and environmental performance.

The Lloyd EcoDistrict was to operate as a special committee of LBID, and partners were given authority and resources to manage the sustainability agenda of the Lloyd EcoDistrict pilot. Several years after its 2011 inception, Lloyd EcoDistrict was formally funded by the Lloyd Enhanced Services District, which committed to provide direct support to Lloyd EcoDistrict until 2024. Lloyd EcoDistrict began as a 501(c)(6) under LBID: its work focused on creating a business case and value proposition for sustainability, directed mainly to employers and employees of Lloyd. As the work developed, however, the organization became a 501(c)(3), and

the mission and vision expanded to include a wider definition of sustainability, and a more inclusive view of the community beyond businesses.

District and Backbone Organization Description

The Lloyd EcoDistrict (LED) is a 501(c)(3), incorporated as an Oregon Non-Profit Public Benefit Corporation. It is the backbone organization for the EcoDistrict.

Lloyd EcoDistrict's mission is to make Lloyd the most sustainable neighborhood in North America. Our primary purpose is to plan and implement a vibrant EcoDistrict in the Lloyd neighborhood of inner north and northeast Portland. Per the Lloyd definition, an "EcoDistrict" is defined as a neighborhood with a broad commitment to accelerate neighborhood-wide sustainability. The Lloyd EcoDistrict has been committed to achieving resource conservation goals, guiding community action and neighborhood investments, and tracking the results over time.

Lloyd EcoDistrict consists of a Board of Directors and staff that operate closely to support any related initiatives in the neighborhood. Lloyd EcoDistrict is a living laboratory for sustainability, pioneering collaborative community-wide scale solutions for social and environmental health. We bring residents, organizations, and businesses in Lloyd to educate, set goals, aggregate resources, and catalyze action. The Lloyd EcoDistrict prioritizes projects and programs that address climate change, social equity, and community resiliency.

Backbone Organization Roles and Responsibilities

We see our roles and responsibilities as a convener, educator and collaborator with all businesses, peoples, and stakeholders within the neighborhood.

Over the past 11 years, Lloyd EcoDistrict has earned a strong reputation for fostering partnerships and leading groundbreaking projects. Some of our significant contributions to the community have been working to reinspire and develop Peace Memorial Park, pollinator corridors, intersection murals, houseless advocacy and support, emergency preparedness, and the Keaton Memorial Art Project. We continue to have success with the Lloyd EcoDistrict Action Forum (LEAF), LED Advantage Membership Program (LAMP), and Building Performance and Benchmarking. We plan to continue this vital work.

At the same time, we are committed to expanding what it means to foster positive, lasting change in our community. As part of the EcoDistrict Certification process, we are strengthening our collaborative governance processes to ensure that all stakeholders, particularly members of BIPOC and houseless communities, have an equal voice in our decision-making, leadership, and strategic direction. The coming years will be transformative for our organization as we continue to deepen and diversify our work in the community.

In 2021 we completed several stakeholder surveys to inform the EcoDistrict Certification work; of the respondents, 38% live, 48% work, 38% shop, recreate, do business, or attend events and 6% own a business in Lloyd. The valuable information gathered in these surveys have informed our Certification process and reimagined roles and responsibilities going forward.

Decision Making Body

Board makeup and appointment procedures

The Lloyd EcoDistrict board is the primary decision-making body. Board members are appointed through a process that includes an application, board review, and approval, as outlined in the Lloyd EcoDistrict bylaws, **Article III: Board of Directors**.

As of spring 2022, the Lloyd EcoDistrict board has 8 members. This number may expand to 17.

Article III: Board of Directors

Section 3. Term and Election

- The term of office for Directors shall be three years. A Director may be reelected without limitation on the number of terms that she or he may serve. The board shall elect its own members, except that a Director shall not vote on that member's own position.
- The initial board terms shall be staggered at one, two and three years. Thereafter, the Board shall make provisions to stagger the terms of Directors so that each year the terms for approximately one-third of the directors shall expire.

Historically, board members were selected based on professional skill set, neighborhood affiliation, and representation of key longtime institutional stakeholders in Lloyd. Today the Lloyd EcoDistrict board is primarily made up of larger organizations in both public and private sectors: engineering sustainability, architecture, federal government, utility, banking, and not-for-profits.

In spring 2022, the board updated its bylaws to specify that, “in recruiting and electing board members, attention will be paid to representation of the diversity of communities and interests within Lloyd, including, but not limited to, government agencies, nonprofits, businesses, developers, advocacy organizations, and others. Attention will also be paid to representation along lines of race, gender, age, immigration status, housing status, etc., with the goal of ensuring that the interests of all community stakeholders are represented among the Directors.”

We have completed a Roadmap Asset Gap Analysis of our neighborhood and acknowledge that our Board does not currently represent all of the communities that we serve within the

neighborhood. As we expand our board in the coming year, we are planning to pay particular attention to ensuring increased representation of people with the following backgrounds and experiences:

- People who identify as BIPOC
- People experiencing and/or who have experienced houselessness or housing insecurity
- Seniors/older residents
- Youth and/or people who work with young people
- People with a public safety and/or mental health background
- People who own small businesses in the neighborhood
- People who identify as LGBTQIA+

The Lloyd EcoDistrict board is currently undergoing an equity assessment and series of workshops in spring/summer 2022. One goal of these workshops is to ensure board members are fully prepared to engage, serve, and prioritize the needs of communities that might not currently be represented. Another goal of these workshops is to revisit the board selection/appointment process to ensure equity and representation of stakeholders across the community, including reworking all board recruitment and selection materials. This updated process will be completed in June 2022 for additional board member recruitment in summer 2022.

Decision Making Procedures

Board Meetings and Decision-Making

The Lloyd EcoDistrict Board meets at least six times per year, alternating months, with the Executive Committee meeting in the off-months. The Executive Committee works with the Executive Director to set the upcoming month's agenda.

Per the Lloyd EcoDistrict bylaws:

Article III: Board of Directors

Section 6. Quorum and Action

A quorum at the Board meeting shall be a majority of the number of Directors prescribed by the Board, or if no number is prescribed, a majority of the number in office immediately before the meeting begins. If a quorum is present, action is taken by a majority vote of the directors present, except as otherwise provided by these By-laws. Where the law requires a majority vote of the directors in office to establish committees to exercise Board functions, to amend the Articles of Incorporation, to sell assets not in the regular course of business, to merge, or to dissolve, or for other matters, such action is taken by that majority as required by law.

Section 11. Action by Consent

Any action required or permitted to be taken at a Board of Directors meeting may be taken without a meeting if the action is taken by all members of the Board of Directors. The action shall be evidenced by one or more written consents describing the action

taken, signed by each director, and included in the minutes or filed with the corporate records reflecting the action taken. Action taken under this section is effective when the last director signs the consent, unless the consent specifies an earlier or later effective date. Consent under this section has the effect of a meeting vote and may be described as such in any such document.

Section 13. Voting Members

All Board members are voting members unless their institutional affiliation or organizations policy prohibits them from voting.

Article VI: Committees

Section I. Executive Committee

The Board of Directors may appoint an Executive Committee. The Executive Committee shall have the authority to make on-going decisions between Board meetings and shall have the authority to make financial and budgetary decisions.

Reporting Board Decisions to the Lloyd Community

Board decisions are regularly reported to the Lloyd community in several different ways.

1. **Budget priorities:** Each summer, after the Lloyd EcoDistrict board approves the new fiscal year budget in July, the Executive Director or Board Chair will publish a letter on the website outlining the budget priorities for the year and how they further the work of the Roadmap.
2. **Programs and activities:** Each spring, the Executive Director or Board Chair will give a public presentation at the Lloyd Open House to share key programs and activities from the Roadmap.
3. **Community engagement:** Annually, the Executive Director or Board Chair will host a town hall and/or community survey to engage community members in active updates and decisions.
4. **Fiscal transparency:** Each spring, the Form 990 will be available on the website.
5. **Biannual report:** Every other year, the Lloyd EcoDistrict Biannual Report will detail a progress report of the Roadmap targets, including accomplishments, any roadblocks, and upcoming priorities.

Stakeholder Resources

Lloyd EcoDistrict could not do its work without the resources and expertise provided by stakeholders across Lloyd. [Exhibit B: Priority-based Asset Map](#) shows some, but not all, of the many stakeholders and assets in Lloyd.

One of the most significant ways community stakeholders can be engaged is by serving on the Lloyd EcoDistrict board. The Lloyd EcoDistrict board will be expanding in 2022 and, as outlined

previously, will prioritize increasing representation of various stakeholder groups. Stakeholders currently on the Lloyd EcoDistrict board contribute to the organization in different ways. For example, the board members representing public entities are unable to fundraise for Lloyd EcoDistrict or ask for contributions, but they can participate on committees, support program implementation, etc. The board members representing private entities can be involved with fundraising and grant application procedures to support the financial growth of the organization. Some board members support the organization with in-kind support such as branding and website, energy benchmarking, or professional development training. Professional staff work with board members on all these initiatives.

Additional stakeholders across the neighborhood provide numerous resources to support the work of Lloyd EcoDistrict. Members of the Lloyd EcoDistrict board, staff, and others currently support the organization in the following ways:

Administration and Development

- **Grant writing:** Lloyd EcoDistrict has contracted with an outside organization A to Be Partners in pursuing grants. This effort is supported by Board members that discuss, review, and support the grant writing efforts.
- **Website and Social Media:** Local universities promote paid internship opportunities to students for communications, website, and social media. Outside contractors support staff and interns to maintain and update our website.
- **Fundraising:** Staff and board work collectively on an annual fundraising campaign, and stakeholders across Lloyd provide financial support. Our 2021 campaign was focused on raising funds to revitalize Peace Memorial Park.
- **Governance:** Lloyd Enhanced Services District (ESD) partners, including Go Lloyd and the Lloyd Community Association, collaborate community efforts for larger impact.

Program Work

Pollinator Placemaking

- **Peace Memorial Park and Holladay Park:** Community members and business partners support placemaking efforts. In 2022, Genentech and Pacific Power are Earth Day Oregon business partners and will support park cleanups. Lloyd EcoDistrict board and staff are actively pursuing grants to support the irrigation updates and renovation of Peace Memorial Park.
- **Pollinator Corridors:** Community members, the City of Portland, Lloyd Community Association, Go Lloyd, Friends of the Green Loop, and others support the replanting and ongoing maintenance of the NE Multnomah Planters and the development of the area around the new Blumenauer Bridge.

Path to Decarbonization

- **LED Advantage Member Program:** In collaboration with Conserve Energy LLC, Lloyd EcoDistrict staff work with a small minority owned business to update older lighting fixtures to LED lighting throughout the Portland metro business. Part of the financial proceeds are then donated to a non-profit serving the neighborhood.

- **Utility Benchmarking:** Lloyd EcoDistrict staff work with local engineering / sustainability consulting firm RWDI to provide an annual ENERGY STAR Portfolio Manager (ESPM) data analysis benchmarking commercial buildings in the neighborhood. Metrics that are measured include ESPM score, EUI and GHG.

Residential Resiliency:

- **Lloyd NET and PDX COAD:** Lloyd EcoDistrict staff work with Portland Bureau of Emergency Management (PBEM) and their Neighborhood Emergency Training (NET) and Community Organizations Active Disaster (COAD) staff to partner on training events, share resources, and build a culture of emergency preparedness in Lloyd..
- **Housing:** In conjunction with Friends of Right 2 Dream Too, residents from Holladay Park Plaza, the Lloyd Community Association, and others, staff works to identify ways to support our houseless neighbors at Right 2 Dream Too.

These programs and initiatives are done in collaboration with key community stakeholders and are woven into the EcoDistrict Certification Roadmap. Collaboration on these initiatives, and others, will increase as the Roadmap is implemented over time.

Imperative Commitment Alignment

This Declaration of Collaboration advances the Imperatives adopted in 2018. Our high-level commitment remains the same: we are committed to advancing Equity, Resilience, and Climate Protection in the neighborhood in a collaborative and community-focused way.

While our broad commitment to these imperatives remains unwavering, a number of the specifics included below have evolved since 2018 based on extensive community feedback, survey data, and input from key stakeholders throughout the roadmap creation process.

For example, “Celebrating diversity within the Lloyd community” has been updated to “The history of the neighborhood is acknowledged and told throughout (particularly that of urban renewal, displacement, and structural racism) by the communities most impacted” and “The rich cultural diversity of today’s Lloyd is uplifted and celebrated.” Similarly, “Increased tree canopy and building out the neighborhood’s green infrastructure” has been updated to “Natural features, including parks, green spaces, and pollinator corridors, are improved and protected.”

For these, and all other activities laid out in the roadmap, Lloyd EcoDistrict is committed to taking continued action with our partners to ensure delivery on these commitments.

Equity: Lloyd EcoDistrict is committed to full and equitable access to neighborhood activities for all, and pledges to integrate equity in neighborhood decision-making and evaluation of results. Our vision is to ensure every member of our diverse community has equitable access to opportunities that enable them to meaningfully participate, lead, and thrive.

Specific ideas and suggestions that address distributional and cross-generational equity include:

- Encouraging collaboration among neighbors
- Celebrating the rich cultural diversity within the Lloyd community, and sharing the history of the neighborhood with regards to urban renewal, displacement, and structural racism
- Providing more resources for the most marginalized in Lloyd (e.g. the unhoused)
- Building equitable access to neighborhood resources, such as public transportation

Resilience: Lloyd EcoDistrict defines resilience as the ability for people and infrastructure to withstand, adapt, and thrive when confronted with all manner of social, economic, and environmental shocks and stresses. With stronger connections between neighbors, individuals have a deeper web to rely on when responding to a crisis. Our board serves as a hub connecting organizations in Lloyd together and building robust networks of collaboration that support this community in moments of adversity. We are committed to building resilience through education, community partnerships, improved infrastructure, and deepening connections.

Specific ideas and suggestions that were raised under the broad theme of Resilience included:

- Developing resources around emergency preparedness in the Lloyd neighborhood (e.g., make safety supply kits available and form a Lloyd Neighborhood Emergency Team, homeless shelters as emergency shelters, etc.)
- Building increased opportunities for community members to interact through public spaces and community-wide events
- Ensuring the built environment promotes ecosystem health
- Using resilience as a framework to make the connection between diversity and equity

Climate Protection:

Lloyd EcoDistrict is fully committed to achieving carbon neutrality as part of this Roadmap. We are actively building a pathway to carbon neutrality by addressing direct and indirect operational CO2 emissions from energy use in buildings, water systems, and infrastructure, solid waste and wastewater management, and transportation.

Specific ideas and suggestions raised under the broad theme of Climate Protection included:

- Ensuring non-car movement through the neighborhood is safe and accessible using alternatives modes of transportation, including walking and biking
- Increased natural features and green infrastructure, including parks, green spaces, and pollinator corridors
- Better communication regarding environmental issues (such as climate change) and neighborhood sustainability performance (such as Lloyd’s annual greenhouse gas footprint)
- More support for alternative forms of transportation, potentially through neighborhood incentives for public transportation and/or the continued development of the Green Loop
- The belief that Lloyd EcoDistrict should strive to be a replicable model for action in other urban neighborhoods

Exhibit A: Lloyd EcoDistrict Boundary

The boundary for Lloyd EcoDistrict is a combination of the Lloyd boundaries recognized by the City of Portland, the Lloyd Community Association, and the Enhanced Services District, and has been informed by community stakeholders engaged throughout this process.

The boundary of the Lloyd EcoDistrict is as follows:

- Western boundary: Along Willamette River, from the Duckworth Dock on the Eastbank Esplanade up to the Broadway Bridge.
- Northern boundary: Along NE Broadway from the Willamette River to NE Schuyler, then along NE Schuyler to NE 17th. This ensures businesses on both sides of NE Broadway are included.
- Eastern boundary: Along NE 17th from NE Schuyler to NE Multnomah, then along NE 16th to I-84. This ensures the residential buildings of Holladay Park Plaza are included.
- Southern boundary: Along I-84 from NE 16th to the Willamette River, including Duckworth Dock on the Eastbank Esplanade.




Image depicts an aerial view of Lloyd with the Lloyd EcoDistrict boundary outlined in yellow as described above.

Exhibit B: Priority-based Asset Map

This priority-based asset map shows some, but not all, of Lloyd’s current assets, ranging from public spaces to community organizations to economic infrastructure.

The 2030 Roadmap lays out additional programs and projects for coming years that will require and/or create the opportunity for new partnerships and stakeholders to be engaged.

Assets are organized by organizational, physical/environmental, and economic/socioeconomic categories. Assets are characterized according to the location of the entity that controls them: primary assets are located within Lloyd and controlled by an entity within Lloyd; secondary assets are located within Lloyd and controlled by an entity outside the district, and tertiary assets are located outside of Lloyd and controlled by entities outside of Lloyd. Assets are also organized by EcoDistricts Protocol Priority areas.




Image depicts a map of Lloyd with organizational, physical, and economic assets marked with purple, green, and blue icons respectively.

1. Partner Outreach


In early April 2022, the 2030 Roadmap had been finalized and the final report was being written to submit it as part of the Lloyd EcoDistrict Certification.

At this point, all organizations that had participated in the development of the Lloyd EcoDistrict Certification Roadmap and/or indicated interest in supporting Roadmap projects were sent a personal email by Lloyd EcoDistrict staff or board with an invitation to review the final Roadmap and affirm their support by signing the Declaration of Collaboration.

This email included a link to the final Roadmap, the full text of the Declaration of Collaboration, and instructions to sign the Declaration of Collaboration via electronic signature.

2. Affirming Support

Once partners were ready to affirm their support and inclusion in this document, they were invited to sign the Declaration of Collaboration via electronic signature. Electronic signatures were collected via Google Form to enable capturing timestamps and all necessary information (name, role, organization, contact information, etc.).
